Tribal Programs Use EN Funding to Build Capacity through Technology

Staff from the Bishop Paiute Tribe provide an overview of how they have leveraged funding from the Exchange Network to build capacity in their water quality program, enabling them to have more robust and responsive monitoring and reporting for decision-makers and the community.

The Bishop Paiute Tribe's Water Quality Control Program (WQCP) has been responsible for receiving and examining drinking water samples across the Owens Valley since 2001.

The program has utilized paper forms for sample collection and analysis since its inception, which has led to challenges regarding storage space, issues when staff are absent or in the field, and susceptibility to loss, damage, or access, potentially compromising sensitive data.

identified Thev а need to transition to a streamlined system for receiving drinking samples, as well as improve quality assurance and quality control processes, and overcome the logistical challenges of paper documents. Through the use of funds from EN grants, the Tribe was able to implement technology solutions that include the use of digital field forms, workflow and reproducible diagrams, scripts for assessing summarizing data, in order to expand and enhance their Water Quality Control Program.

EPA will hold a webinar for Tribes regarding the EPA Policy on Consultation with Indian Tribes and the companion Guidance for **Discussing Tribal Treaty or** Similar Rights. This webinar will provide an overview of the newly revised Policy and Guidance documents. It is EPA's policy to consult on a government-togovernment basis with federally recognized Tribal governments when EPA actions or decisions may affect Tribes. The EPA Policy on Consultation with Indian Tribes establishes standards for the consultation process. The Guidance for Discussing Tribal Treaty or Similar Rights complements the policy by helping EPA staff navigate discussions with Tribes when an agency action or decision may affect such rights. EXCHANGE NETWORK UPDATES

Reinvigoration Effort Continues with Tribal Engagement Meetings

For over two decades, the Exchange Network has served as a platform for innovation and collaboration, enabling technology systems that support standardized data sharing and improved access. As technology and best practices have changed, the Exchange Network did too, but change is accelerating and the Exchange Network needs a renewed vision and dedicated champions to bring that vision into the future.

Exchange Network leaders from EPA, Tribes, States, and Territories have initiated discussions on how to reinvigorate and improve the core elements of the Exchange Network: collaboration, technology, and communication. Several meetings of various EN partners and support organizations have occurred over the past six months, the latest of which was held in November and hosted by the Penobscot Indian Nation. The focus of the meeting was improving Tribal engagement, and the agenda was led by representatives from the Tribal Exchange Network Group (TXG), who will continue to provide updates for Tribes on opportunities to be involved and ways to stay informed. TRIBAL DATA IN THE NEWS

NIH Seeks to Address Health Disparities in Indian Country using Improved Data Sharing and Access Friday, December 1, 2023

The National Institutes of Health (NIH) recently launched the RADx Tribal Data Repository: Data for Indigenous Implementations, Interventions, and Innovations (RADx TDR: D4I), which has been developed to address the disparities recognized in American Indian and Alaska Native communities. RADx TDR: D4I will establish a data repository for researchers and their collaborators interested in working with RADx data provided by research participants to better understand and address the impact of COVID-19 and other health disparities, and inform decision makers and policy developments to address current and future pandemic scenarios. Specific activities will include education and training programs on best practices for responsible data sharing and access, and constructing a secure repository to support data storage, access, harmonization, and monitored sharing of data related to COVID-19 testing and vaccination; all activities will be consistent with Tribal data sovereignty principles.

EPA's Office of Pesticide Programs Seeks Volunteers for Youth Coloring Book Contest

EPA Region 6 and the <u>Tribal Pesticide</u> <u>Program Council's</u> Pollinator Protection Working Group will collaborate with Tribes across the country to develop a youth coloring book that promotes themes of pollinator protection, integrated pest management, environmental stewardship, and climate change through the lens of the Tribal World View. The final product is intended to be translated into various Tribal languages and distributed to Tribal youth across the country.

Volunteers from all 10 EPA Regions are being sought to serve on a working group that will outline the story board for the coloring book. This will include identifying which pollinators to showcase, native plants, native land management practices, and native cultural practices that align with traditional land management methods.
