# E-Enterprise National Meeting 2018 (powered by the Exchange Network)

EE2018 continued the longstanding series of national meetings held by the Exchange Network, with a pivot towards highlighting the E-Enterprise for the Environment initiative. For three days in October, over 300 participants from 44 state agencies, 27 tribal representatives, and U.S. EPA offices convened for the 2018 E-Enterprise National Meeting in Dallas, Texas.

The meeting's re-branding reflects the deep connection between E-Enterprise and the Exchange Network and the desire to promote integrated conversations around process improvement, program modernization, advanced technology, and data management. This year's conference theme of "Shared Stories, Shared Services, Shared Success," provided discussion among attendees to collaborate.

The Tribal Governance Group (TGG) hosted the Tribal Exchange Network Support session for a diverse group of nearly 30 individuals from states, tribes, and EPA, interested in learning more about tribal involvement in the Network. The TGG and the Institute for Tribal Environmental Professionals (ITEP) provided brief overviews of current efforts to support tribes and engage in EN and EE governance initiatives, followed by a robust and informative discussion of topics and questions raised by the audience.

Several tribal representatives delivered individual presentations and served as panelists during the event, including representatives from the Port Gamble S'Klallam Tribe, Native American Environmental Protection Coalition, and Bishop Paiute Tribe.

The <u>E-Enterprise Community Inventory Platform</u>, or EECIP, is an online community and living project database for State, Tribal and, local environmental agencies across the US. The platform currently contains 2,000 projects and enterprise services spanning a broad range of topics including IT, process improvement, advanced monitoring, and Exchange Network grant project information.

By joining EECIP, you can:

- >> Add your agency's projects. Projects posted can be under consideration, under development, or finalized.
- >> View partner agencies' projects, enterprise services and other information.
- >> Find potential collaborators for Exchange Network Partnership and other grant programs.
- >> Get ideas for shared services and find example RFPs, position descriptions, and other types of documents.
- >> Build community by participating in discussion threads to get answers and connect with peers.
- >> Customize content displays based on your interests.

#### **EN Grant Solicitation**

The Exchange Network Grant Program provides funding to states, territories, and federally recognized Indian tribes to support the development of the National Environmental Information Exchange Network. The primary outcome expected from Exchange Network assistance agreements is improved access to, and exchange of, high-quality environmental data from public and private sector sources. With this outcome in mind, applications should demonstrate support for and results toward EN program priorities.

A draft version of the FY 2019 Exchange Network Grant Program Solicitation Notice is now available for stakeholder review. See: <u>Draft Fiscal Year 2019 National Environmental Information Exchange Network Solicitation Notice</u>. The final solicitation notice will be available soon and will be announced on our tribal listsery.

The EN Grant Program is soliciting project proposals that use the EN to:

- >> Facilitate sharing environmental data, especially through shared and reusable services.
- >> Streamline data collection and exchanges to improve its timeliness for decision making.
- >> Increase the quality and access to environmental data through discovery, publishing, outbound, and analytical services so it is more useful to environmental managers.
- >> Develop foundational EN shared services to reduce burden and avoid costs for co-regulators and the regulated community.
- >> Expand and improve participation in the EN by strengthening the requisite information management and technology capabilities for interested parties to fully participate in the EN.

<<>> EPA is initiating consultation and coordination with federally recognized tribes on a proposed regulatory revision to the Clean Water Act (CWA) section 404 permitting program. In the Spring 2018 Regulatory Agenda, the EPA announced the Agency's plan for the first comprehensive revision to the existing section 404(g) regulations since 1988. The Administration recognizes the need for greater clarity on the requirements for state and tribal assumption of the section 404 permitting program and identifies this issue as one of its priorities. The EPA intends to modernize these regulations and foster a greater interest by the authorized tribes and states in assuming this authority.

# <>>> Oil and Natural Gas Sector: Emission Standards for New, Reconstructed, and Modified Sources Reconsideration

On September 11, 2018, the U.S. Environmental Protection Agency (EPA) proposed targeted improvements to the 2016 New Source Performance Standards (NSPS) for the Oil and Natural Gas Industry, including amendments to the fugitive emissions monitoring requirements in the rule. The proposal would significantly reduce regulatory burden, saving the industry tens of millions of dollars in compliance costs each year. The changes also would streamline requirements and improve alignment between EPA's rule and existing state programs.
